Introduction

We live in a hyper-connected world in which everyday activities are increasingly being conducted online. The Commonwealth Telecommunications Organisation (CTO) is responding to this reality by convening a week of events that will feature activities designed to help keep members safe in cyberspace. The CTO's Statutory Meetings will also be held during this week.

Digital Week 2024 will be convened from 20–24 May 2024 for CTO members, Commonwealth Ministers, public officials and business leaders. The activities planned for Digital Week 2024 are as follows:

20 May 2024

D> Executive Committee

The CTO Executive Committee will review recommendations concerning the CTO's strategies and policies; consider the financial and the strategic plan, draft budget, workplan, Annual Report and business plans prior to submission to the Council. This meeting is open to Executive Committee members only.

21–23 May 2024

Open to all CTO members and ICT and business stakeholders, CyberKeys, is an immersive experience that will demonstrate and explain the extent of the risks in cyberspace; provide insight into how the risks can be minimised and traps avoided. The event will offer solutions for escaping the traps in cyberspace and options for recovery and restoration.

There will be an exhibition of innovative ICT solutions and cybersecurity tools for CTO members, the judiciary, law enforcement officials and other stakeholders.

23 May 2024

Presentation of Digital Transformation project results

The CTO will present the results of a research project entitled *Digital Transformation: critical success factors and challenges across the Commonwealth*, that explores the critical success factors and challenges of digital transformation across the Commonwealth.

23 May 2024

Doutreach to the judiciary and law enforcement officials

There will be a special session for attorneys general and law enforcement officials to discuss ICT solutions and tools for enhancing and strengthening the cybersecurity ecosystem.

23 May 2024

D> Networking activities

There will be opportunities for members to caucus and networking sessions for all participants.

24 May 2024 ▷ **62nd Council**

Open to Representatives of Full Member Countries and other CTO members, the 62nd Council will determine the broad policies and strategies of the CTO; examine and approve the CTO's business plan and budget, and in the light of that, report and adopt any decisions it considers appropriate. The Council will also elect the members of the CTO's Governing bodies.


